Use this form to apply for a new water access licence with a specific purpose under section 61(1)(a) of the *Water Management Act 2000*.

A water access licence permits the licence holder to take water allocations credited to the licence in accordance with the terms and conditions of the licence.

Water taken under a water access licence with a specific purpose can only be used for the specific purpose for which the licence was granted.

Who can apply?

Any person can apply for a new water access licence with a specific purpose.

Who can use this application form?

Responsibilities for granting and managing water supply work approvals and water use approvals are shared between the Department of Planning and Environment (the department) and WaterNSW.

This application form is for use by the department's customers:

- government agencies, including other NSW government agencies, local councils and the Commonwealth
- state-owned corporations
- water utilities, water supply authorities and licensed network operators under the Water Industry Competition Act 2006
- mining activities
- irrigation corporations
- public schools and hospitals
- Aboriginal communities and businesses.

An individual found guilty of an offence against section 344 is liable to a penalty not exceeding \$500,500.

An access licence or approval may be suspended or cancelled under the *Water Management Act* 2000 in certain circumstances. These include if the holder of the license or approval is convicted of an offence under that Act.
