4. Draft vision

The NSW Government has developed the draft NSW Water Strategy as part of a suite of long-term strategies to maintain the resilience of the state's water services and resources over the coming decades.

The proposed vision for the draft NSW Water Strategy is sustainable water resources for thriving people, places and ecosystems, both now and for future generations.

Additionally we are implementing a Reconciliation Action Plan which is a reflection of our commitment to create improved economic, health and social outcomes for Aboriginal and Torres Strait Islander peoples.

5. Draft objectives

6. Draft guiding principles

The draft strategy also proposes seven principles to guide the long-term strategic planning for water resource management in NSW. These principles work in tandem with the draft objectives to guide development and implementation of actions.

- systems thinking to optimise outcomes
- data-enabled planning and decision-making
- transparency and accountability to engender community trust
- · forward thinking to build preparedness and resilience
- · giving effect to Aboriginal rights and access to water.

7. Opportunities, challenges and actions for improved statewide water management

The draft NSW Water Strategy outlines seven strategic priorities for action, focused on meeting the core objectives based on the NSW Water Management Act 2000. These strategic priorities are:

- 1. Build community confidence and capacity through engagement, transparency and accountability
- 2. Recognise Aboriginal rights and values, and increase access to and ownership of water for cultural and economic purposes
- 3. Improve river, floodplain and aquifer ecosystem health, and system connectivity
- 4. Increase resilience to changes in water availability (variability and climate change)
- 5. Support economic growth and resilient industries within a capped system
- 6. Support resilient, prosperous and liveable cities and towns
- Enable a future focused, capable and innovative water sector.

Under each priority the draft strategy identifies several opportunities and challenges, and a total of 41 proposed actions to improve water management across the state.

Do you have any comments on the seven strategic priorities identified?

The strategic priority areas are appropriate and are consistent with the priorities Hunter Water have identified for water management.

Do you have any comments on any of the proposed actions identified?

Hunter Water offers the following commentary in relation to actions under Priority Areas 3, 4 and 6.

Action 3, 1: This action acknowledges the lack of long term water plans for coastal catchments. The Williams River currently has no agreed water quality objectives within relevant strategic plans (e.g. the LLS Hunter Local Strategic Plan, The Greater Hunter Regional Water Strategy). The Lower Hunter Water Security Plan will identify projects that will ensure the ongoing provision of safe drinking water however it is working in the absence of NSW State Level water quality objectives.

Action 3,2: Hunter Water supports landscape scale action to improve river and catchment health. It is noted that the suggested actions involve partnerships and continuation of existing programs. Hunter Water is of the view that policy and regulatory responses could also form a part of the solution set e.g. increasing consent conditions for development in the drinking water catchment. Further Hunter Water strongly supports calling out the identification of drinking water catchments within the Draft Strategy. Action 3.5: Refer to comments for Action 3.1

Action 4.4. Hunter Water supports the delivery of liveability outcomes through an integrated water management approach. The recommendations of the 2020 Federal Government Productivity Commission Research Paper and draft recommendation 5.3 of the NSW Productivity Commission's Green Paper should be be incorporated to remove impediments in the policy environment. https://www.pc.gov.au/research/completed/water-cycle/integrated-urban-water.pdf.
Action 6.8. In addition to the comments provided against Action 4.4, Hunter Water notes that governance options for enhancing the delivery of whole of water cycle solutions are missing from the Draft Strategy. Many IWCM projects are at the boundaries of water utility or local government roles and it is not always clear which entity should lead. Institutional responsibility options should be considered for delivery against Action 6.8.

Are there any additional opportunities, risks and challenges that should be considered in the draft strategy?

Action 6.8. In addition to the comments provided against Action 4.4, Hunter Water notes that improving governance and institutional arrangements to facilitate the delivery of whole of water cycle solutions are missing from the Draft Strategy. The multiple parties involved int eh governance and delivery of IWM projects make these processes challenging and often mean that positive outcomes for customers and the environment are not realised. Institutional responsibility options should be considered for delivery against Action 6.8.
