Fish Friendly Water Extraction



About the Better Bidgee Program

The NSW Government is investigating a range of measures for the Murrumbidgee River system as part of rescoping the Yanco Creek Offtake Project. These measures are part of a new Better Bidgee program (the program).

Following the Murray-Darling Basin Ministerial Council meeting in April, Water Infrastructure NSW has rescoped the Yanco Creek Offtake Sustainable Diversion Limits Adjustment Mechanism (SDLAM) Project and investigated options that could be supported by the community.

Our focus over the past few months has been evaluating the years of community feedback regarding the need to improve connectivity, environmental, cultural and community outcomes.

We know that these issues can only be addressed by taking a holistic, system-wide approach to water infrastructure planning and operations, working in tandem with changes in water policy and strategy. We also know that feedback from our stakeholders and communities is critical to ensuring we progress the best options for delivering outcomes.

We have recently launched a major consultation and engagement program, which will enable us to work side-by-side with communities to investigate solutions to create a Better Bidgee. This is a shift towards beneficial outcomes for communities and the environment.

Options are currently being investigated by the project team, most of which are in the very early planning stages. Community feedback and input will play a crucial role in shaping which initiatives are progressed, and what these initiatives look like, to deliver a Better Bidgee.

About the proposed Fish Friendly Water Extraction initiative

Many communities, businesses and farmers rely on water from the Murrumbidgee for their livelihood. However, water extraction can inadvertently cause harm to fish that get sucked into pumps and diverted into channels, where they are lost from the waterways.

The proposed Fish Friendly Water Extraction initiative would deliver a major program of installing modern fish screens and other infrastructure works to stop fish and debris entering pumps and diversions.

Potential benefits


This initiative would have significant environmental and economic benefits including:

- up to 90 per cent reduction in fish loss from irrigation infrastructure, saving millions of native fish each year
- reduced operating costs to farmers with less money and time spent maintaining their pumps
- potential water savings, as less debris in supply lines means more water efficient delivery.

The location of the proposed Fish Friendly Water Extraction initiative is shown in the map below.


