

# Western Weirs

## Western Weirs project overview

The NSW government has engaged WaterNSW to prepare a strategic business case (SBC) for the holistic management and operation of the weirs in the Barwon-Darling and Lower Darling system. The project area extends from Mungindi on the NSW/QLD border to Wentworth in the far South West of NSW.

There are over 29 weirs along the Barwon-Darling River and the current infrastructure is known to have a number of deficiencies. These include poor condition of weirs, no system level functionality, flow regulation limitations, town water supply and water security concerns and unclear responsibility and ownership of structures. WaterNSW is investigating a holistic approach to the management of the weirs.

If fully implemented, the Western Weirs Program is expected to provide enhanced water delivery efficiency, improvements to river connectivity, long-term water availability and access for far west regional communities.

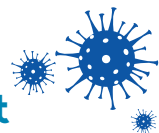
WaterNSW has assembled a project team to develop the business case. The project is in the early stages of consultation with stakeholders, to inform communities and stakeholders and receive feedback to input into the SBC. However, we are pausing on most of this consultation until the restrictions put in place by COVID-19 are eased.

Meeting with stakeholders face-to-face and providing equal opportunities for all stakeholders to be consulted is an important part of our engagement approach.

## COVID-19 and what it means for the Western Weirs project

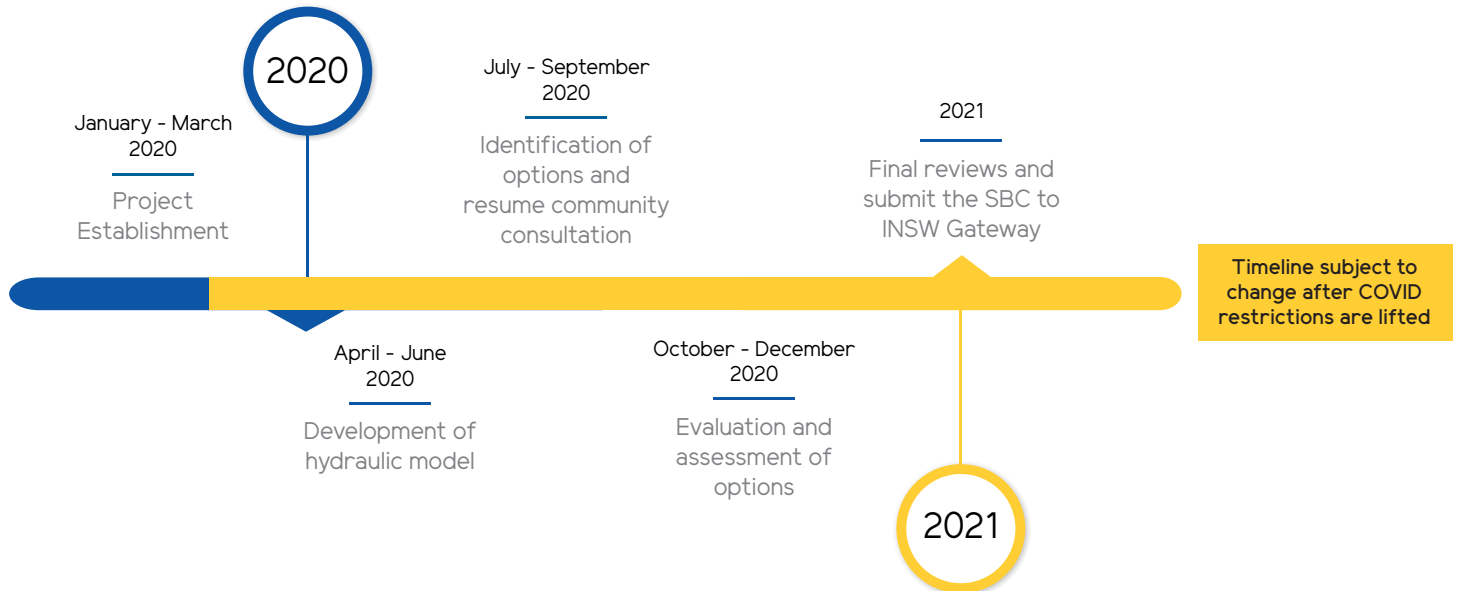


WaterNSW is committed to the health and safety of our people, customers and the communities we work in. We are also committed to providing the services essential to the people of NSW and to the continuation of our projects.

## Communications and engagement

Online meetings with the far west councils to obtain initial feedback and collect information is continuing. The project team will be contacting communities as soon as they can travel and arrange meetings to receive feedback on the project.

## Next steps

WaterNSW is continuing to develop the SBC for consideration of funding decision by Government. The timeline above is subject to change due to the impacts of restrictions from the COVID-19 pandemic.
